

No.GP-24-MCG-1018-SFS-23-J :- In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Medical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj.3 of 2008), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate Courses) Rules, 2017, namely:-

1. These rules may be called the Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate Courses) (Third Amendment) Rules, 2018.
2. In the Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate Courses) Rules, 2017, in rule 4, in sub-rule (3), before the existing proviso, the following proviso shall be inserted, namely:-

“Provided that for the purpose of admission for the academic year 2018-19 only, the candidates who have studied and passed 10th standard from the school located outside the State of Gujarat shall also be eligible.
