No.: GP-17/MCG/1018/SFS/23/J:- In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Medical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj.3 of 2008), the Government of Gujarat, hereby makes the following rules further to amend the Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate Courses) Rules, 2017, namely:-

1. These rules may be called the Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate Courses) (Second Amendment) Rules, 2019.
2. In the Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate Courses) Rules, 2017, in rule 5, in sub-rule (2), after clause (d) [Economically Weaker Sections (EWSs): 10%], the following proviso shall be added, namely:-

Provided that the reservation of the seats for Economically Weaker Sections (EWSs) will be applicable only to those colleges or institutions where the Ministry of Health and Family Welfare and Ministry of Ayush, Government of India have increased the number of seats to implement the 10% EWSs reservation quota without affecting the existing number of general and other quota seats.
